### **PLANT SALE AND BENCHING CONDITIONS.** **\*\*ALL FIRE ANT REGULATIONS MUST BE ADHERED TO\*\***

- (1) Lodging plants for benching or sale at a The Brisbane Orchid Society Inc. (BOS) show indicates agreeance to abide by BOS Plant Sales and Benching conditions herein.
- (2) Visiting Society members who have at least two (2) good quality orchids benched or in a display for judging in the show are eligible to lodge plants for sale.
- (3) There are no limits for orchid sale plants.
- (4) Plants will be accepted for sale on Friday from 4.00pm to 7.00pm. Any further information required please contact the BOS Plant Sales Co-ordinator Tara Nguyen on 0421 515 336.
- (5) Plants must be clean, virus free and well established. The plant sales co-ordinator or his/her representative shall have the right to refuse any plant which does not meet a satisfactory standard.
- (6) All plants are received on the basis that every reasonable care will be taken to safeguard the plants, but no responsibility will be accepted for any loss or damage incurred during the BOS Show/Plant Sales, or while in transit. The owner shall have no claim whatsoever against the BOS or its representatives.
- (7) At the time of benching, a completed BOS Plant Sales and Benching Registration form is to be given to the BOS Plant Sales Co-ordinator or his/her representative along with the plants which must be correctly labelled.
- (8) It is a requirement to have barcode labels on all pots of plants made available for sale, as this is the only method BOS Plant Sales Staff will be using to process the sale of plants.
- (9) No plant, once submitted, is to be removed without the prior approval of the BOS Plant Sales Coordinator or his/her representative.
- (10) Commission of 15% will be deducted by BOS from the proceeds of the plants sold, and the balance paid by direct deposit to the participating member or visiting member.
- (11) Unsold plants must be collected immediately following the close of the Show.
